Philadelphia Family Child Care Consortium (PFCCC/Pipeline)-Project

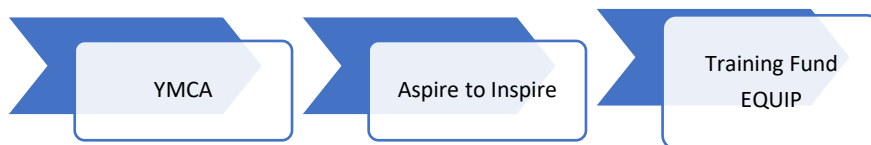
Early Childhood Education stakeholders developed the concept of a Referral Continuum, a pipeline of supports that takes providers from initial licensing through accreditation. Through research and collaboration with community partners, PFCCC was created. PFCCC aims to support the process of Family Child Care (FCC) Providers pursuing quality improvement initiatives.

PFCCC will strengthen services, develop new initiatives, improve communication and advocacy, and create new partnership opportunities, all to support FCC Providers in improving quality and sustainability.

Pipeline (PFCCC's Nickname)

The process of which FCC Providers are connected to our Core Agency Partners and enrolled into an initiative that supports them through program start-up phase to STAR 3 & 4. Our Core Agency Partners are responsible for various components of the process as follows:

- ❖ **YMCA Family Child Care Network:** Start-up/New FCC Providers
- ❖ **Aspire to Inspire:** STAR 1 FCC Providers
- ❖ **District 1199C Training & Upgrading Fund:** STAR 2 FCC Providers
- ❖ **EQUIP:** STAR 2 FCC Providers (Seasonal Entry)



PFCCC also has Support Agency Partners that are not directly linked to the Pipeline outlined above; however, they offer additional support to FCC Providers throughout the initiative.

Core & Support Agency Partners- Coordinate delivery of services and activities to FCC Providers.

This includes, but not limited to:

- Moving providers through STAR levels
- Providing Professional Development & Technical Assistance
- Providing start up, licensing, and accreditation support
- Offering educational opportunities
- Supporting the Pipeline overall using outreach and recruitment strategies

Mentor/Coaches- Expert FCC Providers that provide mentoring and coaching to new and inexperienced FCC Providers and lead regionally based Community of Practice groups in the 6 Meeting House (Hub) areas. Mentor Coaches passes on skills, share experiences, and provides guidance to mentees (FCC Providers) to assist them with creating and achieving program goals.

Meeting Houses- A FCC Provider Community of Practice that is peer led by Mentor Coaches and in different geographic areas of the city offering evening hours and open some Saturdays. Meeting Houses also have virtual experiences as well.

Each Meeting House offers, but not limited to:

- Professional Development and networking opportunities
- Consulting
- Access to computers and resources
